Jomella Watson-Thompson, PhD

Associate Professor, Department of Applied Behavioral Science, University of Kansas



Dr. Thompson holds a PhD in Behavioral Psychology and a Masters of Urban Planning from the University of Kansas. She applies behavioral science methods and interventions to improve how communities address issues related to community health and development. Her research has focused on neighborhood development, healthy youth development, and prevention, including substance abuse and violence prevention. Dr. Thompson supports community capacity-building efforts to address social determinants of health through community-based participatory research in urban neighborhoods and disparate communities. She has researched the effects of community-based processes and intervention to promote mobilization and change in communities. David J. Cox, PhD, MSB, BCBA-D

Dr. David J. Cox, Ph.D., M.S.B., BCBA-D has worked within the behavioral health industry for 17 years. He began working in behavioral health by providing and then supervising Applied Behavior Analysis (ABA) programs for individuals with autism spectrum disorders. After 8 years of clinical work, Dr. Cox went back to school to earn his PhD in Behavior Analysis from the University of Florida, Post-Doctoral Training in Behavioral Pharmacology and Behavioral Economics from Johns Hopkins University School of Medicine, and Post-Doctoral Training in Data Science from the Insight! Data Science program. Since 2014, Dr. Cox's research and applied work has focused on how to effectively leverage technology, quantitative modeling, and artificial intelligence to ethically optimize behavioral health outcomes and clinical decision-making. Based on his individual and collaborative work, he has published over 45 peer-reviewed articles, three books, and over 150 presentations at scientific conferences.

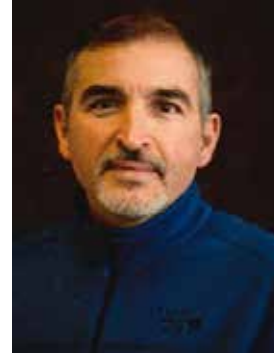

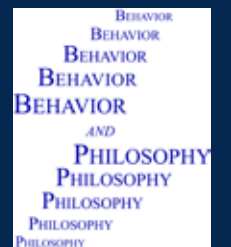

Call for Submissions

Behavior and Philosophy publishes articles dedicated to theoretical issues concerning behavior analysis as well as allied behavior sciences (e.g., conceptual analysis; methodological discussions; reflections on epistemology and ontology; ethical and political investigations).

All manuscripts in accordance with *Behavior and Philosophy's* scope will be considered for publication after a double-blind review process by two anonymous reviewers invited by the Editor for the task.

Behavior and Philosophy adopts the continuous publishing model of publication. Finished the copy-editing process, articles accepted for publication will be published [online on Behavior and Philosophy site](http://online.on.Behavior.and.Philosophy.site) in a continuous flow. The journal volumes will be closed by the end of each year with the papers published during this period. The continuous publication process promotes speed and agility in the process of availability of research. The Century Psychology Series: An Important Contribution to Behavior Analysis

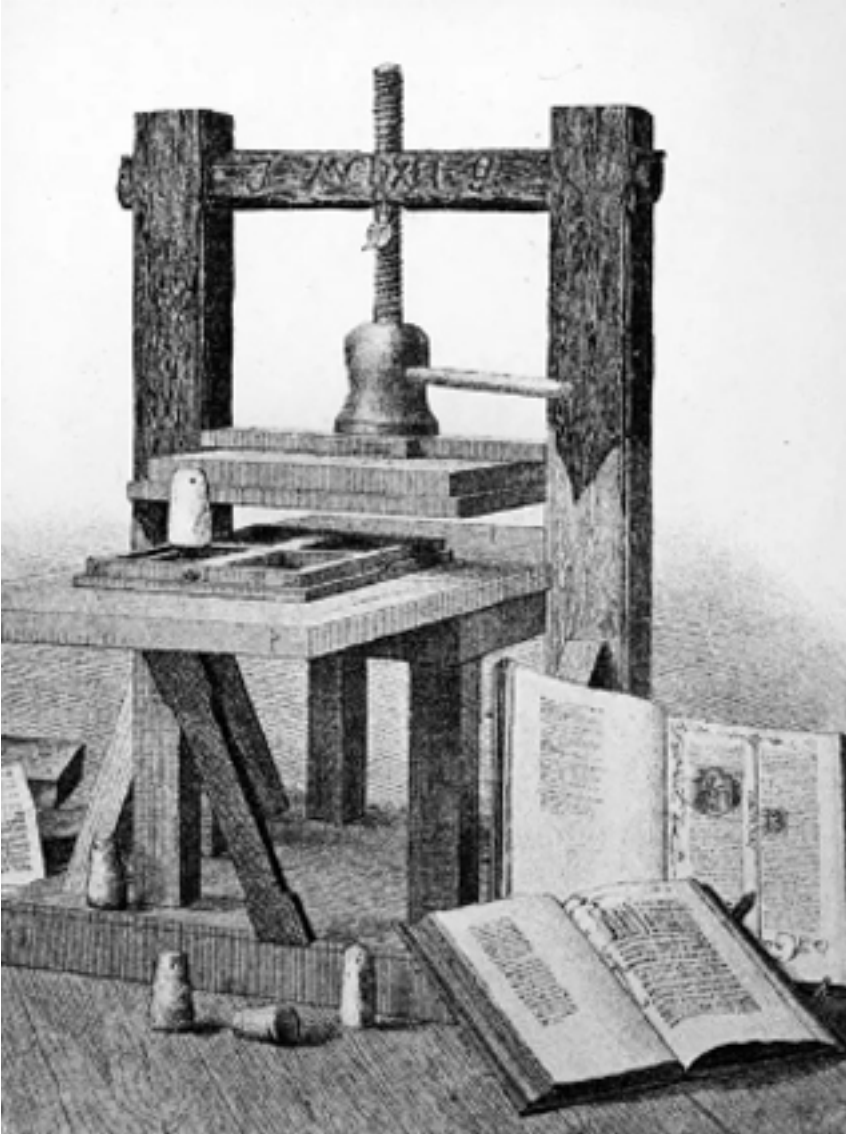


Figure 1. Engraving of the printing press invented by Johannes Guttenberg in the mid-1400s (Getty Images). Source: <https://www.thoughtco.com/johannes-gutenberg-and-the-printing-press-1991865>

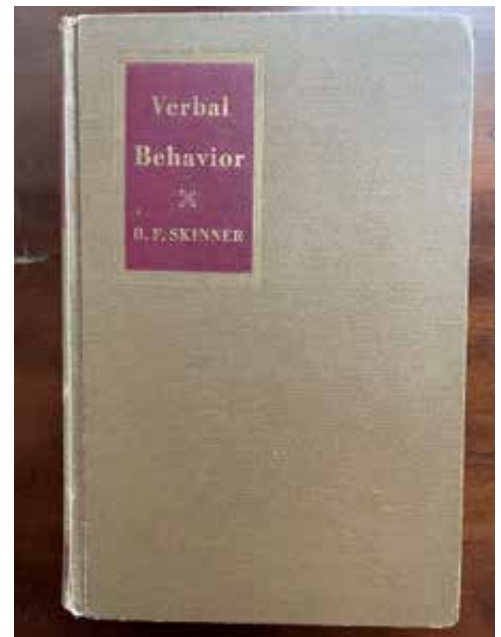


Figure 2. A first edition of B. F. Skinner's *Verbal Behavior*. The cover style, immediately recognizable to behavior analysts of a certain age, was standard for volumes in the Century Psychology Series of that period.

Long before the world wide web, for thousands of years books were the prime means of distributing knowledge. Books originally were created by hand and then by means of printing presses such as the one shown in Figure 1, invented by Johannes Guttenberg in Germany in the mid-1400s. Supplemented first by letters and later by letters organized more formally into journals, books were central to the growth of the sciences, including psychology. Within behavior analysis, one series of books has no equal in terms of its role in disseminating

the ideas that formed modern behavior analysis. This series was launched with the 1929 publication of E. G. Boring's *A History of Experimental Psychology*. Boring's classic text was followed in the series by other important texts, not the least of which was Skinner's *Behavior of Organisms* in 1938. Thereafter, many of Skinner's seminal works appeared as part of the series, including *Schedules of Reinforcement* (1957, with C. B. Ferster), *Verbal Behavior* (1957; see Figure 2), *Cumulative Record* (1959, 1961, 1972), *Technology of Teaching* (1968), and *Contingencies of Reinforcement* (1969). The series also contained books by other authors that were instrumental in shaping the discipline, including the two edited volumes by Werner Honig (*Operant behavior: Areas of Research and Application* [1966] and, with J. E. R. Staddon, *Handbook of Operant Research* [1977]), volumes on child development (1961 and 1965) by Sid Bijou and Don Baer, W. N. Schoenfeld's *Theory of Reinforcement Schedules* (1970), and Travis Thompson and John Grabowski's programmed textbook on *Reinforcement Schedules and Multioperant Analysis* (1972), to name but a few.

The series' first, highly influential, editor was R. M. ("Mike") Elliott (1887-1969; see Figures 3 and 4). Recommended for the position by none other than E. G. Boring, Elliott was, in 1924 at the time of his appointment, professor and chair in the Department of Psychology at the University of Minnesota. A remarkably talented psychologist and administrator (he was Department Chair from 1919-1951), Elliott was responsible for the inclusion in the series of not only for the aforementioned books, but also such classics as E. C. Tolman's *Purposive Behavior in Animals and Men* (1932) and Clark L. Hull's *Principles of Behavior* (1943). Skinner's connection with Elliott was deep, for it was Elliott who hired Skinner as an assistant professor at the University of Minnesota in 1936 and who lamented Skinner's departure in 1945 to become Chair of Indiana University's Psychology Department (Elliott, 1952, p. 90). Elliott uniquely recognized and attracted talented people to do interesting things in psychology. In 1952, he appointed another rising star of behavior analysis to the important role of assistant editor of the series. Kenneth MacCorquodale (1919-1986) first became influential in behavior-analytic circles for his analysis, with Paul Meehl, of the distinction between hypothetical constructs and intervening variables (MacCorquodale & Meehl, 1948) and subsequently for two classic analyses of Skinner's book on *Verbal Behavior* (MacCorquodale, 1969; 1970). Of Skinner, MacCorquodale subsequently wrote to Elliott, in a letter dated February 8, 1964, as part of a discussion of several potential authors for books in the series:

As for Fred's writing, I am in total agreement with you: let us publish anything we can get our hands on, Science and Human Dignity if necessary, Technology of Teaching if possible (although I believe we have a firm contract for that?). As for demilitarizing him he is, as I know, completely intractable and will not change a comma so don't waste your breath." (Box 1, Folder 49, page 2; R. M. Elliott archival material, University of Minnesota Library)

Of his work as Editor of the Century Psychology Series, Elliott wrote that "nothing that I have ever put my hand to has been more satisfying" (Elliott, 1952, p. 91). Nothing that he could have put his hand to could have had greater influence on subsequent generations of behavior analysts.

Tech, Tools, & Tips

In this recurring column, Janet will describe some of her favorite free or low cost technology, tools, and tips that may be of interest to the CCBS community.

A Picture is Worth a Thousand Words...or Maybe a Few?

One question I get asked a lot is "Where do you get the images for your presentations?" I tend to like big bold images, often with kids in them (since I do talk about education...a lot...), and like many of us, I don't really want to spend a great deal of money on purchasing images to license. Luckily there are several image sites that offer free (both royalty free and copyright free) images for public use.

For several years my go-to site has been **Unsplash** (<https://unsplash.com>) a huge, vibrant library of beautiful images and stock photography. Although Unsplash is now owned by Getty Images, users still have free access to millions of photos. Photographers contribute their original works under the Unsplash licence, allowing you to use amazing images commercially or non-commercially without crediting the photographer (although it is always appreciated when credit is given). You can save the images you like to your own albums and folders to find again later.

Another of my favorite free sites is **Pixabay** (<https://pixabay.com>), which hosts a constantly growing community of artists sharing their copyright free images, videos, and music. Since content is released under the Pixabay License, they are legal to use without asking for permission or giving credit to the artist - although again, giving credit is a nice thing to do. The site offers over 2.7 million+ high quality photographs, drawings, videos, and music, and offers a robust search function. When you create an account, you can "favorite" images to save in your personal library.

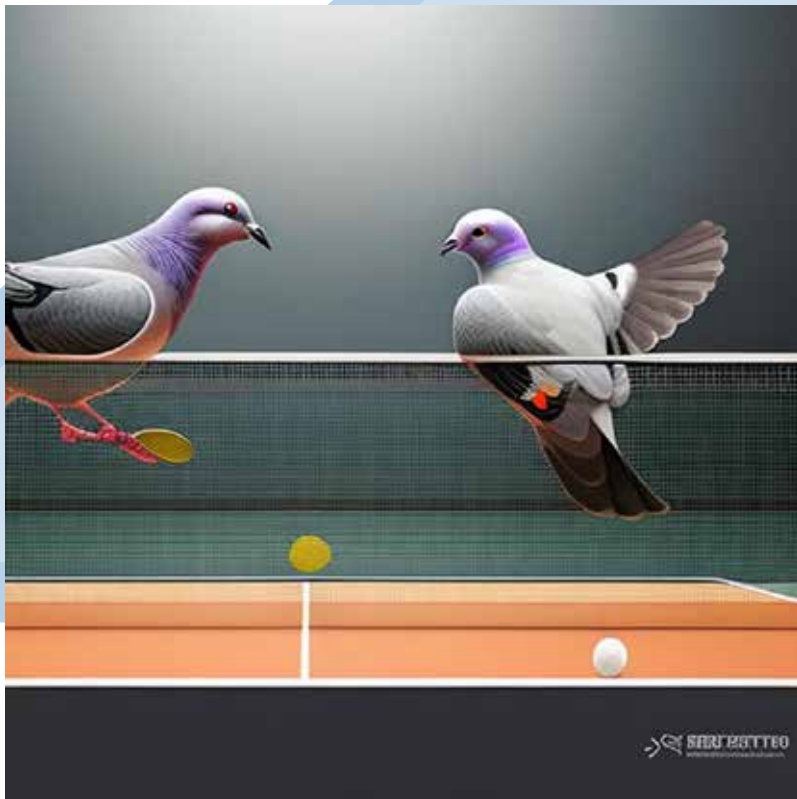


Another image source I often use for original photographs grouped by artist is **flickr** (www.flickr.com). Attribution requirements differ for each image ~ always check the requirements listed on the same page as the photo. And while the catalog of images is a bit smaller, I have found a few gems on **Pexels** (www.pexels.com), images that weren't cross-shared on other sites. Pexels has a good search function and don't require attribution (although, I'll say it again, giving credit is always a respectful thing to do).

While the sites above offer images to use for free, there are guidelines for use. Most sites ask that identifiable people are not portrayed in a bad light or in an offensive manner. Often, they also shouldn't be used to endorse a particular product or service and users often don't have the right to sell the image to others. It's important to check the Terms of Use on each of these sites. An important caveat is that on most of these sites, anyone can upload images, even ones they did not take and have no rights to. I've found it's useful to follow a particular artist, making it more likely they are posting their own work. A useful source of information about using images is from **copyrightlaws.com** (<https://www.copyrightlaws.com/legally-using-images-presentation-slides/>) or this linked post (<https://friendlystock.com/avoid-get-sued-using-free-stock-photos/>)



AI Generated Images

Images from Unsplash and Pixabay have been the foundation of my visuals, yet I confess to be frequently dabbling in the AI image generated world. AI-generated images are becoming increasingly popular, especially in design and social media. Based on text prompts (such as "two pigeons playing ping pong in detailed digital art style") AI algorithms generate corresponding (or sometimes completely unexpected) images. Often several images are generated and user can choose the one that fits their vision. Some sites support refinement of images created until it is "just right" (or close enough).

Text to Image tools often accepts prompts in many languages and can work off descriptions of objects, people, surroundings, or colors. Free sites and tools I've used to create AI-generated images include **Picsart** (<https://picsart.com/ai-image-generator>), used to create the image) and the extremely popular **DALL-E** (<https://openai.com/dall-e-2>), requires an OpenAI account. Those using **Canva** to create presentations are probably already familiar with its free AI art generator.

Other free AI image generators include:

Stable Diffusion/DreamStudio (<https://stablediffusionweb.com>)

BlueWillow (<https://www.bluewillow.ai>)

Kapwing (<https://www.kapwing.com>)

These tools allow you to create myriad images by simply typing your prompt and letting the AI do the rest. And, for better or worse, it's just the beginning of what AI can create for us. Perhaps a future column will cover AI generated audio and video (very cool, but also fraught with the potential for misuse — which is definitely a column topic in its own right).

Also remember to give credit where credit is due. As with any image, the creator or source of an AI-generated image should be acknowledged, minimally with the name of the website or tool used to generate the image.
